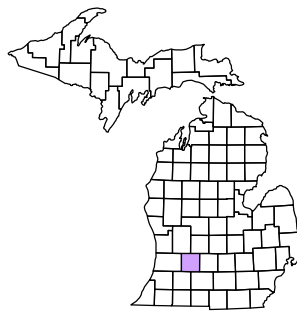

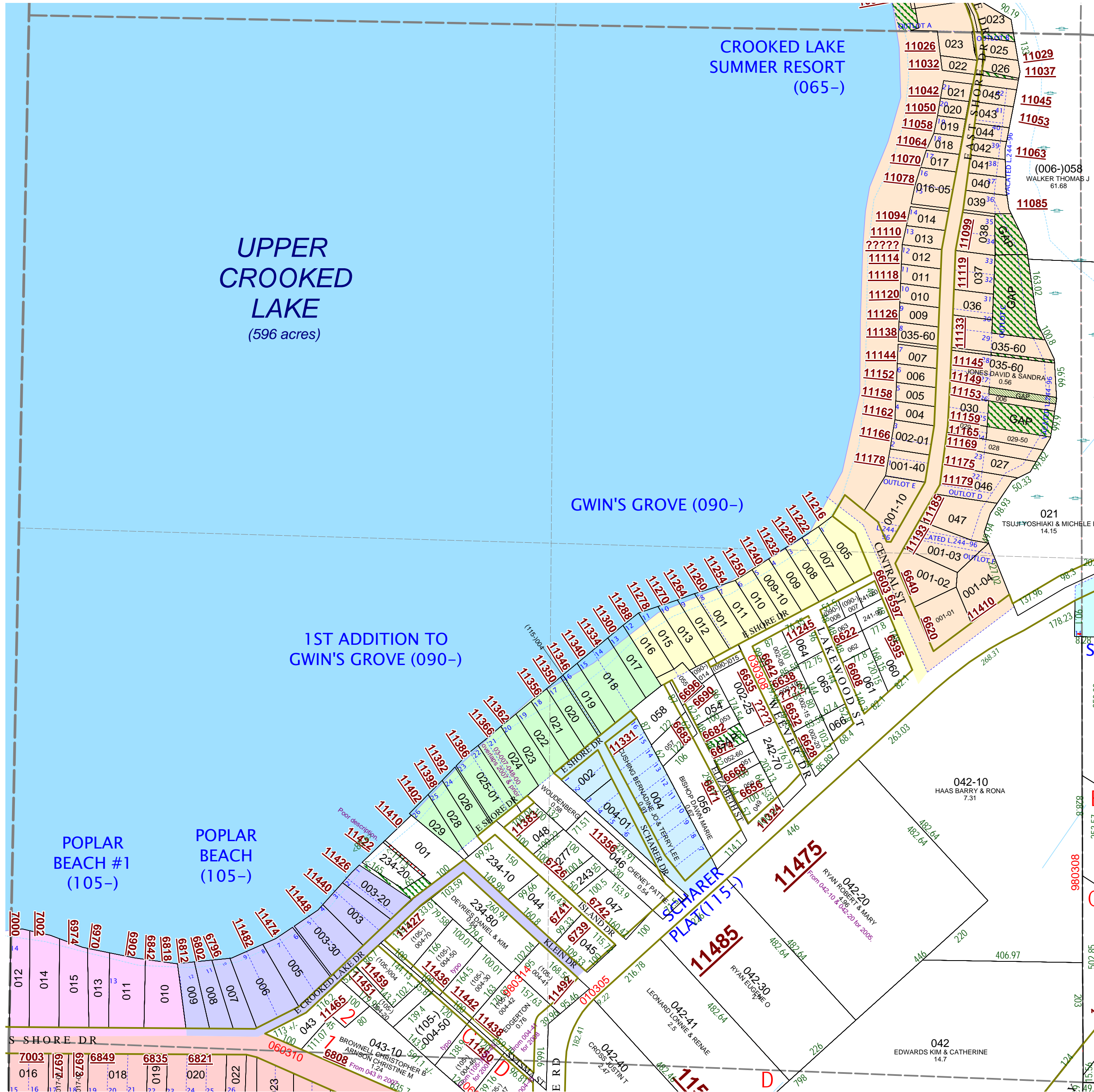

08-03-065-023-00 needs to include lake front parcel (not on R#1008351).

GAP in outlet B owned by the Estate of Mary Baker, Raymond H. Baker heir designate in L.152-121.

GAP in outlet C owned by Cornelius J. VerCies in L.188-557.

GAP in outlet C owned by Melvin Raab in L.640-877.

08-03-065-006-00 needs to include gap to the east because it didn't get it all the parcels from the combination made in 2005.

08-06-065-030-00 needs to include gap parcel to its east. See R#1165062.

08-03-007-052-60 needs to include gap parcel to the northwest.

08-03-007-234-20 has a poor point of beginning. I think they assumed the south corner of Gwin's Grove was on the southerly point of the old road way rather than on the south corner of the lot.

08-03-105-007-00 has the plat name misspelled, it should be "POPLAR" not Popular.
08-03-105-008-00 has the plat name misspelled, it should be "POPLAR" not Popular.
08-03-105-004-50 has a small typo, change "TH 49D 1M 29S E 79.58 FT" to "TH S49°01'29"E 79.58FT".
