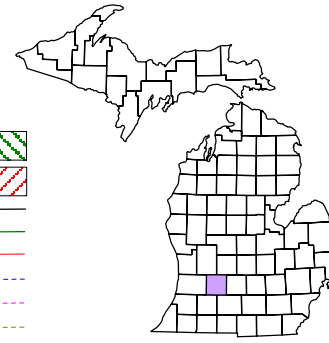

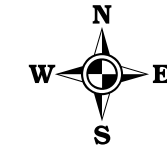

08-41-022-022-00 suddenly included the units Towne Center Condo lying south of the road when the developer retracted those units from the project in June of 2008.

GAP in lot 58 owned by Hastings City Bank in L.391-28.

GAPs west of Thornton Addition owned by Virginia & Vincent Imbro in L.262-88.

08-41-105-014-10 is missing half a foot in its course measures. See WD L.630-160.

GAP in block 44 owned by Robert Allen in L.57-70.

GAP Paul's Tract Village of Middleville. Last deed is a Life Estate to Mary Paul from Charles & Mary Paul in L.40-147, but the Village says they own it.

08-41-043-001-00 describes no real property, this lot was platted over by Shupe's Addition and there is nothing left to assess. Property is actually owned by the township now.

08-41-046-006-00 needs to include parcel to its east deeded in R# 1021527.

08-41-045-008-00 overlaps 003-00 but has the same owner.

GAP in block 45 owned by Melissa A. Dietrick (1/3 interest) & John D. Dietrick (2/3) interest in L.118-342.

GAP in block 45 owned by Cora French survivor of R. Sydney French in L.148-588.
